Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform you that Tradio Exim Private Limited, a subsidiary of V R InfraspacE Limited, has initiated legal proceedings under Section 138 of the Negotiable Instruments Act, 1881 against Rudrarutu Associates and Others.

The detailed disclosures as required under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Master Circular no. SEBI/HO/CFD/PoD2/CIR/P/0155 dated November 11, 2024 is as below:

Brief Details of the Dispute/Litigation: Tradio Exim Private Limited had supplied rice to Rudrarutu Associates. In discharge of payment obligations, a cheque amounting to Rs. 2,87,708/- was issued by Rudrarutu Associates, which was subsequently dishonoured due to insufficient funds. A criminal complaint under Section 138 of the Negotiable Instruments Act, 1881 has been filed by the subsidiary company on May 12, 2025 to recover the outstanding dues.
2.	Expected financial implications, if any, due to compensation, penalty etc.	No adverse financial impact is expected on the listed entity. The complaint seeks recovery of dues owed to the subsidiary and enforcement of legal remedies.
